Introduction



REAL-TIME CIVILIAN MONITORING

A small camera device placed on the outside of the civilian's vehicle will monitor the interaction with law enforcement in real-time.



ANTI-POLICE BRUTALITY SYSTEM

The system is designed to provide a safeguard against potential police brutality during traffic stops and other law enforcement interactions.




CIVILIAN-CONTROLLED MONITORING

The system allows the civilian to control the monitoring process, ensuring transparency and accountability during the interaction.

The Need for Civilian Monitoring

Recent high-profile incidents of police brutality, including the deaths of George Floyd, Breonna Taylor, and others, have highlighted the pressing need for a comprehensive system to monitor and record interactions between civilians and law enforcement during routine traffic stops and other encounters. A civilian-led monitoring system would serve as an independent check on police conduct, providing transparency and accountability to help prevent future instances of excessive force or misconduct.



The Monitoring System

CAMERA DEVICE

The proposed system involves a small, discreet camera device that is mounted on the exterior of a civilian's vehicle. This device will continuously record the interaction between the driver and the officer during a traffic stop.

REAL-TIME TRANSMISSION

The footage captured by the camera device will be transmitted in real-time to a remote monitoring center, allowing for immediate oversight and review of the interaction.

REMOTE MONITORING CENTER

The remote monitoring center will receive the live feed from the camera device, enabling trained personnel to observe and analyze the traffic stop encounter as it unfolds.

Key Features

REAL-TIME MONITORING

The system will provide real-time monitoring of police interactions with civilians, allowing for immediate identification and response to potential incidents of brutality.

AUDIO AND VIDEO RECORDING

The system will utilize advanced audio and video recording capabilities to capture comprehensive evidence of police-civilian encounters, ensuring objective and reliable documentation.

CIVILIAN REPORTING

The system will enable civilians to directly report incidents of police brutality through a user-friendly mobile application, empowering the community to actively participate in the monitoring process.

AUTOMATED INCIDENT DETECTION

The system will employ advanced algorithms to automatically detect and flag potential incidents of police brutality, triggering immediate review and response by the monitoring team.

SECURE DATA STORAGE

All recorded data and reported incidents will be securely stored in a centralized database, ensuring the integrity and accessibility of the evidence for accountability purposes.

Privacy Considerations

STRICT ACCESS CONTROLS

The system will implement robust access controls to ensure that the footage can only be accessed by authorized personnel for legitimate purposes.

ENCRYPTED DATA STORAGE
